**18.01.3 Minutes**

**18.01.4 Matters Arising**

It has been noted the abandoned vehicle parked on the village green has now been removed, although no contact has been made to the Parish Council, following the correspondence sent. The planters have also been removed.

The Councillors thanked Mr Armstrong, EDC, for arranging to have the kerb dropped at the Car Park, at the bottom of the village green, to enable wheelchairs etc to have easier access to the pavement leading to the Village Hall. Work likely to be carried out Feb/March 2018.

**18.01.05 Village Green Guidelines**

The Councillors discussed this matter at length, also inviting the Public to have their say and ideas.

After much deliberation, the Councillors resolved not to have guidelines.

The Village Green, as with all Village Greens, are for recreational activities and cannot be policed if written guidelines were drawn up. The Parish Council therefore will continue to act upon any complaints received in a fair manner or should the Councillors note any items that are placed on the Village Green that shouldn't be there, will bring the matter to the Parish Council to decide the action to be taken.

It was resolved, when writing the Newsletter for the AGM, to reiterate the fact it is a Village Green.

Unfortunately, parking on the Village Green cannot be helped as some properties are unable to park on the own property due to space etc, but it would be appreciated if the vehicles did not block the highway, travel across the green itself or be driven too sharp into the corners of the green thereby cutting the grass up and carrying mud on to the road.

The Councillors will look at re-instating the corners in the Spring, with earth and grass seeds.

The Councillors resolved to transfer £1000 to the Current Account. Clerk to arrange a letter for the signatories to sign to transfer these funds.

2018/2019 Precept - After much discussion it was resolved to increase the precept to £5000, as it was reduced last year to £2500, with the previous four years being £2700.

Emails have been received from 123-Reg, with £11.99 for the Domain Renewal and £50.26 for the Web Package, an increase from £35.86. Clerk to contact M Joyce to ascertain if these prices are acceptable.

The Pot Hole repairs - Materials required to carry out the filling of the pot holes on the Cart Roads. Resolved Councillor Healey contact Metcalfes and order more scalpings.
