### 18.09.3 Minutes

### 18.09.4 Matters Arising

It was reminded that the repairs to the seat on the village green is still to be carried out, which has been duly noted and Councillors are to check that they have the appropriate materials and a date be set to carry out the repairs.

Regarding the Blue Bin Bags, it has been recommended that the full, tied blue bag is placed within a dustbin ready for collection to ensure birds and rodents cannot access them and pull them apart.

### 18.09.5 Milburn Village Hall

An email has been received from Mrs A Evan, Secretary for Milburn Village Hall Committee asking if a Councillor would like to appoint a Councillor on to the Village Hall Committee, the Councillors declined the invitation but still wish to be kept informed. The Village Hall Committee informed the Parish Council they are to register the land with the Land Registry, the Councillors had a query regarding this, as the Parish Council is the Custodian Trustee. The Clerk to contact Mrs Evans and obtain clarification.

### 18.09.6 Footway Lighting

Regarding the taking over of Footway Lighting in Milburn. Confirmation has been received there is only the one light, outside No.1 Croft View, as the light attached to the Village Hall is not applicable. The cost of this light would be £121 - 2018/19, £91 - 2019/20, £61 - 2020/21 and £30 2021/22. After much discussion it was agreed not to sign and enter into this agreement. The light will be kept in working order, basic repairs only, until 31<sup>st</sup> March 2022, after that should the light fail it will be removed.
